1) Breeder represents and warrants to Buyer the Cat has had the following vaccinations:

- **The “Cat” will need a 3rd FVRCP vaccination at 16 weeks old**
- **Cat is NOT to be vaccinated for FeLV, FIV or FIP – (will Null and Void the health guarantee)**
- **“Buyer” understands that the “Cat” being purchased has already been sterilized through a spay or neuter procedure at the time of receipt of said “Cat”**
- **Buyer acknowledges receipt of a Florida Health Certificate performed by a Florida Licensed Veterinarian for said “Cat”**

Health Guarantee/Warranty:

Breeders state to the best of their knowledge, at the time of purchase the “Cat” is in good health, FeLV/FIV negative, and free of any life threatening illnesses, infections, internal and external parasites, ear mites, fleas and ringworm. **With respect to such guarantee, Breeder requires Buyer to have “Cat” examined by a licensed veterinarian and tested for FeLV and FIV within 3 (three) business days of the contract agreement date. Buyer is required to mail to the Breeders, within 7 (seven) days of the exam date, a detailed report written by a veterinarian describing the kittens health status at the time of the initial exam.** If this “Cat” dies an untimely death due to a Genetic or congenital defect (FeLV, FIV, FIP are not genetic and are specifically excluded) within (120) days of purchase date, Buyer and Breeder agree to replace said “Cat” of equal value at such time as one becomes available. Breeder will only offer the choice of 2 cats to the Buyer to fulfill their replacement obligations. To qualify and receive the replacement “Cat”, Buyer must provide Breeders with all medical history reports, a detailed Autopsy report and a letter written by a licensed veterinarian stating the exact cause of death including the description of the “Cat’s date of birth, name, sex, color and pattern. The Autopsy cost is at the expense of the Buyer. Buyer assumes the responsibility for arrangements and cost to take possession of their replacement “Cat”. Warranties will not be honored if ownership changes.

It is not uncommon for a “Cat” to develop an Upper Respiratory Infection, diarrhea, teary eyes or sneezing from vaccinations or stress of leaving and entering a new environment. Stress induced illnesses are NOT covered by the health guarantee. Breeders require the Buyer to isolate “Cat” from existing pets for at least 7 days, preferably 14-21 days. We, the Breeders are NOT responsible for any veterinarian bills incurred by the Buyer once the Buyer takes possession of this “Cat”. All sales are final, NO RETURNS, REFUNDS, OR EXCHANGES except as outlined by the terms of this agreement.

The well being of the “Cat” being of critical importance, Buyer shall comply with the following restrictions and obligations with respect to possession of the “Cat”:

- Continue to feed either Chicken Soup for the Cat Lover’s or Royal Canin Adult Fit and or Royal Canin Special Dry Formulas
- The “Cat” will not be mistreated and must have fresh food and water and a clean litter box at all times.
- The “Cat” **will not be denied veterinary care at any time.**
- Buyer shall **keep the “Cat” indoors only.** The “Cat” will not be caged, or kept in an unsuitable room, basement or garage. The “Cat” will be kept in an appropriate cat carrier during all forms of transportation.
- The “Cat” shall **NOT BE DECLAWED.** The Buyer will provide scratching post(s) for the “Cat”.

- Upon the event Buyer is unable to keep the “Cat”, the **Breeder has First Right of Refusal**. The Buyer agrees to never give/sell/lease the “Cat” to a shelter, rescue, pet shop, research laboratory, third person or left outside to survive on its own.

Failure of Buyer to execute any of the requirements, restrictions or obligations contained in this contract will result in Breach of Contract and the health guarantee will be Null and Void and at no time will a replacement “Cat” or monetary reimbursement be owed or offered to the Buyer.

Laws of the State of Florida applicable to contracts to be performed in the State of Florida shall be applicable to this agreement. If any provisions of the agreement conflict with the Law of Florida, the provisions of this agreement not in conflict shall continue to bind the parties, and the provisions in conflict shall be modified in accordance with the law. Any disputes that arise from this agreement shall be in the jurisdiction of Bay County, Florida court. All legal fees and cost incurred by the Breeders and Buyer shall be the responsibility of the Buyer. Breeders can not be sued for an amount more than the original purchase price of “Cat”.
